The mission of the Grizzly Flats Community Services District is to maintain the highest ethical standards for its Board members and employees while providing quality water in a fiscally responsible manner for the community of Grizzly Flats.

Scheduled Rate Increase

As a reminder, customers will see water rates change on the water statements dated July 31, 2018. The basic rate will change to **\$63.95** and the volumetric charge will change to **\$1.17 per hundred cubic feet**. The District staff and Board of Directors evaluated the prior year's revenue and expenses in June to verify that the scheduled rate increase was needed to continue to operate in a fiscally responsible manner.

The table below shows the adopted 5 Year Plan for water service charges:

*hcf = One hundred cubic foot = 748 gallons.

The rate structure includes two rate components: (i) a monthly basic rate for all customers within the District's service boundaries that have a meter installed and (ii) a volumetric charge based on the volume of water actually consumed by the customer. This rate change was approved in 2016 during the Prop 218 process. Long-Term Water Conservation Legislation Fact Sheet

We've received some questions about the recent legislation signed by Governor Brown regarding long term water conservation. The new legislation is directed at "urban water suppliers". GFCSD is not considered an "urban water supplier" at this time. Although, water conservation is important to our District and we encourage all of our customers to use their water wisely, the framework adopted in the new legislation will not have an impact on you as a water customer at this time. You are welcome to attend a meeting to see your District in action.

There's no requirement to know the water industry. The General Manager is responsible for the dayto-day operations of the District. The Board's job is to set strategic goals and objectives for the District and ensure accountability by reviewing polices, budgets, monthly financial and operational reports. The only requirement is that your primary residence must be within the GFCSD boundaries and you must be a registered voter of the District. GFCSD staff is here to support you in your role as a Board member and we work as a team to maintain the highest standards for our customers.

We also have an election coming up in November where all five of our Board seats are up for election! Anyone who is interested in a seat on the Board will need to file with El Dorado County Elections Department before <u>August 10th</u>. This deadline is approaching quickly, so please don't delay if you have any interest in serving on the Board.
