The Consumer Confidence Report (CCR) is an annual water quality report issued by Grizzly Flats Community Services District as required by the Safe Drinking Water Act (SDWA). The purpose of the CCR is to inform you of the quality of your drinking water. In previous years, GFCSD has mailed its customers a printed copy of the CCR. State Water Resources Control Board has expanded its interpretation of the SDWA to allow for electronic delivery of the report. This allows GFCSD to reduce paper consumption and minimize printing costs.

#### **Water Service Disconnections**

On June 11, 2021, Governor Newsom signed Executive Order N-08-21, which sets September 30, 2021 as the date the moratorium on water service disconnections for non-payment expires. This means all GFCSD customers must pay all past-due water charges by that date to avoid disconnection.

If you are unable to pay your full balance by September 30, 2021, contact our office as soon as possible to see if you are eligible for a payment arrangement.

#### Water Supply & Conservation

"How's the reservoir look?" is a common question asked by our customers. The reservoir level is an easy way to gage our available water supply. Currently, the reservoir is full and spilling, but it may not stay that way!

In the summer, the water flow in nearby creeks that provide us with water start to decrease (some go completely dry) and we become dependent on the water in the reservoir. The reservoir level will start to go down when our water demand is greater than what is coming in from those creeks. With a long, dry, summer ahead of us, we will need to work together to conserve our water supply.

The District has three conservation stages that ask for different amounts of conservation from water customers. The stages are triggered by the water level in the reservoir. We will post updates on our Facebook page (<a href="https://www.facebook.com/grizzlyflatswater">https://www.facebook.com/grizzlyflatswater</a>). If emergency conservation becomes necessary, we will also post notices at the Grizzly Flats Post Office, send out notices with the water bills and email customers!

Start now by being mindful of the water you use. Be aware of water flowing out of hoses or faucets. Is there a way to capture that water and put it to use somewhere else? Do you have leaks that need to be fixed? The valve has extensive corrosion damage and needs to be replaced. After the work is done, the pond will refill naturally this fall. In the meantime, please feel free to use the picnic tables. Also, if you happen to see our "Grizzly Pond Rules" sign, please return it. It was stolen from the entrance of the property a few weeks ago. Thank you!
